Introduction

The UMD Work Environment Survey assessed specific aspects of faculty work environment, such as faculty perceptions of their own professional growth, institutional and unit supports for professional growth, climate for work-life balance, fair treatment and diversity, and satisfaction, all of which have been linked to retention and advancement. There were 488 tenure track respondents, approximately 32% of full-time UMD tenure track faculty in fall 2010. Here major findings are reported for tenure track/tenured respondents in the College of Behavioral and Social Sciences. Respondents

The analytical sample for this report is the tenure track faculty respondents of the UMD Faculty Work Environment Survey from BSOS (n=51), 29% of the 2010 tenure-track/tenured BSOS faculty. Of the BSOS tenure track respondents, 59% were female and 41% were male. Regarding race, 10% were faculty of color, 88% were White faculty, and 2% were international faculty. Lastly, BSOS respondents were 29% Assistant Professors, 24% Associate Professors, and 47% Full Professors. There were 12% BSOS respondents who were administrators (Chairs, Directors, and Deans).

Data Analysis

We first ran descriptive statistics (e.g. frequencies and means) on each survey item for all respondents. Then, we conducted statistical testing (chi-squared analyses, t-tests, or ANOVA)

for differences by gender. Testing for racial and rank differences could not be conducted due to low sample size. Means, standard deviations and statistically significant differences at $p < .05$, $p < .01$, or $p < .001$ are noted within the tables in Table 15. Any differences described within the text of this report refer to statistically significant differences unless otherwise noted. When conducting statistical testing on a number of items (such as the case in this report), caution should be used when interpreting differences in any one single survey item. Throughout the results section we also include some open ended comments related to specific themes.

Results

Organizational Commitment and Intent to Leave

TOP FINDINGS

- 26% of BSOS participants stated they were likely to leave the university in the next two years (v. 31% for all of UMD respondents).
- 91% of BSOS participants stated that there was at least one faculty member in their unit who left in the past three years (v. 87% for all of UMD respondents).
- 39% of BSOS respondents had had an outside offer while at UM (compared to 41% of all UMD respondents)
- For BSOS participants who wanted to leave, the most frequent reasons listed for wanting to leave UMD were for a higher salary (58%), for a more prestigious institution or department (33%), or for a better work-life balance (33%).

Satisfaction with Department and UMD

TOP FINDINGS

- 65% of BSOS participants were satisfied with their overall experience working in their unit and 55% were satisfied with their overall experience at UMD (compared to 61% and 60% respectively for all UMD respondents).

- There were two specific aspects of the faculty experience that were rated more highly by BSOS respondents than UMD respondents: transparency of decision-making and autonomy in one's role.
- The most BSOS participants were satisfied with the autonomy they have in their role* (87%) and the diversity on campus (70%). These are the same top two satisfaction areas for all UMD respondents.
- The least BSOS participants were satisfied with the salary and benefits (30%) and the assistance they received in finding grants (19%). These are the same bottom two satisfaction areas for all UMD respondents.

Fair Treatment and Diversity

TOP FINDINGS

- The majority of BSOS respondents perceive that diversity is important (89% for BSOS v. 80% for UMD), units work hard to create diverse representation* (94% for BSOS and 79% for UMD), and female faculty and faculty of color receive fair treatment (53% and 59%, respectively, for BSOS v. 60% and 57% for UMD).
- 26% of BSOS faculty agree that they have experienced discrimination (v. 23% for UMD).

Work-Life Climate

TOP FINDINGS:

- 48% of BSOS respondents were satisfied with their unit's culture for work-life balance (v. 42 for UMD).
- 29% of BSOS respondents agreed that the university does what it can to make family life and the tenure track compatible (v. 25% for UMD).
- 31% of BSOS respondents agreed that there are role-models for work-life balance (v. 30% for UMD).
- Similar to UMD respondents, BSOS respondents rated many of UMD's policies and programs for work-life balance as valuable, but few respondents took advantage of these programs and many had not heard of the programs.

It is important to note that the part-time tenure track policy was established December 17, 2009.

The Family Care Resource and Referral Service began in fall of 2010. The tenure delay policy was established March 6, 2007.

Tenure and Promotion Process

TOP FINDINGS

- More than half of BSOS participants perceived clear requirements and fair processes* for tenure (77% and 84%, respectively, for BSOS vs. 68% for both for UMD).
- 74% of BSOS respondents believe the process for advancing to Full Professor is fair (vs. 59% for UMD) and 59% of BSOS respondents perceived clear requirements for promotion to Full Professor (v. 52% for UMD).
- BSOS responded more favorably than UMD on the fairness of the tenure process and the ability of faculty to succeed at UMD if they work hard.
- Yet, 44% of BSOS respondents had concerns about their own advancement (v. 41% of UMD).

Evaluation of Teaching, Research, and Creative Work

TOP FINDINGS

- More than half agreed that their unit supports effective teaching (52% BSOS v. 45% UMD), interdisciplinary scholarship (61% BSOS v. 44% UMD), engaged scholarship (50% BSOS v. 40% UMD), or collaborative research* (71% BSOS v. 49% UMD).

Management of Teaching, Research and Service Responsibilities

TOP FINDINGS

- 94% of BSOS respondents felt in charge of their research (v. 90% UMD).
- 85% of BSOS respondents felt managing their teaching responsibilities were under their control* (v. 69% UMD).
- About half of both BSOS respondents and UMD respondents felt in control of their participation in service activities or able to say no to additional service without consequences for their career.

Recognition

TOP FINDINGS

- More than half of BSOS respondents believed that their research (67% v. 66% UMD), service (62% v. 54% UMD), and teaching contributions (62% v. 57% UMD) were valued by colleagues in their unit.
- 42% of BSOS respondents said they had been nominated by someone at UMD for an award (v. 40% UMD).

Leadership Opportunities

TOP FINDINGS

- About a third of BSOS respondents said they would like to hold a leadership position at UMD at the institution (35%) and unit (37%) levels (v. 37% for UMD).
- 61% of BSOS respondents had leadership self-efficacy (v. 60% for UMD).

Information, Communication, and Decision-Making

TOP FINDINGS

- A majority of BSOS participants felt open to share their opinions (69% v. 63% for UMD), that major decisions are made with adequate input from faculty* (81% v. 54% UMD), and that their voice does make a difference in their department (72% v. 60% for UMD).
- About half of BSOS participants agreed that their unit was transparent in terms of information sharing (49% v. 35% for UMD), resource allocation* (43% v. 32% for UMD) or salary increases* (49% v. 31% for UMD).
- BSOS respondents were more favorable about the transparency of resource allocation and salary increases and the input that faculty have in major decisions when compared to UMD respondents overall.

Faculty Learning

TOP FINDINGS

- 69% of BSOS respondents reported learning a great deal regarding their research in the past year (v. 72% for UMD).
- 49% of BSOS respondents reported that their unit provides an environment that stimulates their academic learning (v. 50 for UMD) and 34% of BSOS respondents reported that the university provides such an environment (v. 43% for UMD).
- The pressure to publish was noted as a barrier to learning for 22% of BSOS respondents (v. 28% for UMD), and the pressure to seek grants a barrier to learning for 35% of BSOS respondents (v. 39% for UMD).

Professional Networks and Collegiality

TOP FINDINGS

- Most BSOS faculty respondents perceived their professional network was helpful in a number of areas, including influence, visibility, feedback, advice, and awareness of professional opportunities.
- 60% of BSOS respondents said that their core discussion network was mainly off campus (v. 63% for UMD).

Perceptions of Productivity

TOP FINDINGS

- 54% of BSOS respondents ranked themselves as more productive than researchers in their field and rank nation-wide (v. 51% for UMD).
- 28% of BSOS respondents ranked themselves as less productive than researchers in their field and rank nation-wide (v. 27% for UMD).
- 41% of BSOS respondents believed their unit views them as more productive than researchers in their field and rank nation-wide (v. 38% for UMD).
- 37% of BSOS respondents believed their unit views them as less productive than researchers in their field and rank nation-wide (v. 33 for UMD).

BSOS Gender Differences

TOP FINDINGS

- In most areas of the survey, BSOS responses did not differ significantly by gender ($p < .05$).
- While three individual items showed differences by gender, no patterns of differences emerged.
